#### **Item 1. Call to Order of the Bicycle/Pedestrian and Trails Advisory Committee**

#### **Item 2. Public Comment**

Ronald Bartcher, President of the Mims Community Group stated the East Central Regional Rail Trail has begun construction at the Trail Head on Aurantia Road. This Trail Head is the beginning of the Equestrian Trail and currently does not have any equestrian features such as, appropriate parking and turn around, source of water and horse corals. Mr. Bartcher requests this committee to formally recommend the remaining \$150,000.00 from the year 2000, North Brevard Parks and Recreation Referendum, signed for Equestrian trail features is used to

put in the needed equestrian amenities. Mr. Barcher would also like this committee to work closely with the parks department to make sure the equestrian features do get added.

Ms. Kraum stated that she has been working with the Brevard County Parks and Recreation and their new Director, Mary Ellen Donner in regards to the equestrian plans. The Parks Department is aware of the needed equestrian features and they are close to formalizing a plan. Ms. Kraum stated she will keep the BPTAC Committee updated.

Ms. McCall provided two informational pieces highlighting the Coast to Coast Trail, a quarterly county magazine and a Titusville flyer. Bike Florida will be coming to Titusville on March 20, 2018 for 3 days bringing 620-680 cyclists that will tent camp, RV and stay in local hotels.

Ms. Sterk stated that she researched trail counters and found out that another metropolitan planning organization used an Internal funding source.

Ms. Kraum requested that Ms. Sterk provide her with the information she gathered so she can do some research and see if it is possible with our funding and programs.

Ms. Sterk replied that she will follow up. Ms. Sterk also stated Parrish Park segment in Titusville is at 60% plans and reviewing them now.

Mr. Hann stated there is a lot of progress on the trails in the north and would like to know if they will be consistently branded.

Ms. Kraum stated there isn't a plan to brand the trails as "Brevard" but the Coast to Coast trails plan to stay cohesive, but keep the local flavor. St. John's River to Sea Loop Alliance is working on branding initiatives as well.
