Performance Measure Targets: Safety (PM1), Bridge and Pavement (PM2), System Performance (PM3), and Transit Asset Management (TAM)

A RESOLUTION, adopting the Florida Department of Transportation (FDOT) Safety (PM1), Bridge and Pavement (PM2), System Performance (PM3), and Transit Asset Management (TAM) performance measures and targets for Calendar Year 2023 and agrees to plan and program projects so that they contribute toward the accomplishment of the FDOT targets and Space Coast Area Transit, 2022 Transit Asset Management (TAM) Plan

WHEREAS, the Space Coast Transportation Planning Organization (TPO) is the designated and constituted body responsible for the urban transportation planning and programming process for the Palm Bay-Melbourne and Titusville Urbanized Areas; and

WHEREAS, the Fixing Americas Surface Transportation Act, and the continuing Moving Ahead for Progress in the 21st Century's (MAP-21) overall performance management approach, requires state Department of Transportation's to establish performance measures in a number of areas, including setting performance measures and targets; and

WHEREAS, on October 1, 2016, the Transit Asset Management rule from the Federal Transit Administration became effective, applying to all recipients and subrecipients of Federal transit funding that own, operate, or manage public transportation capital assets; and

WHEREAS, public transportation providers are required to set and report transit targets annually and share with TPO, for the purpose of being incorporated into the Transportation Improvement Program (TIP) and Long Range Transportation Plan (LRTP); and

WHEREAS, the Florida Department of Transportation has adopted Safety (PM1), Bridge and Pavement (PM2), and System Performance (PM3), performance measures and targets for Calendar Year 2023, as reflected in Attachment "A"; and

WHEREAS, the Space Coast Area Transit (Transit) has set and adopted a Transit Asset Management (TAM) plan with performance measures and targets for rolling stock, equipment, infrastructure and facilities; and

WHEREAS, the TPO wishes to establish and adopt its Safety, Bridge and Pavement, System Performance, and TAM performance measures and targets as those of the FDOT and Transit; and agrees to work with the State, Transit, and stakeholders to address areas of concern within the metropolitan planning area and into the necessary planning processes and documents.
