#### **Membership:**

The Transportation Disadvantaged Local Coordinating Board (TDLCB) is an advisory committee composed of 17 voting members appointed by the Space Coast Transportation Planning Organization's (TPO) Governing Board.

TDLCB quarterly meetings are typically scheduled (February, May, August, and November) on the third Monday of the month from 10:30 a.m. to 12:00 p.m. at the Brevard County Government Center (2725 Judge Fran Jamieson Way Viera, Florida 32940: Space Coast Room, Building C, Second Floor). All meetings are open to the public and include sections for public comment.

#### **Responsibilities:**

The primary responsibilities of the TDLCB are as follows:

- Identify local service needs and to provide information, advice, and direction to the Community Transportation Coordinator (CTC) on the services to be provided to the transportation disadvantaged population.
- Assists in establishing eligibility guidelines and trip priorities.
- Reviews the CTC Evaluation.
- Review and approve various documents, such as Transportation Disadvantaged Service Plan.
- Review strategies and seek innovative ways to improve cost effectiveness, efficiency, safety, working hours and types of service within the county.
