



Agenda Items:

<u>Item 1. Call to Order of the Technical and Citizen Advisory Committees and Pledge of</u> Allegiance

Technical Advisory Committee Chair, Cliff Graham, called the meeting to order at 9:30 a.m. and welcomed those in attendance. All stood for the Pledge of Allegiance.

Item 2. Public Comment

None.

Item 3. Executive Director's Report

Georganna Gillette, SCTPO Executive Director, advised the Committees of any pertinent items not covered on the agenda. Perfect attendance for the 2023 TAC/CAC meetings was acknowledged. The TAC members were Bob Musser, Jared Francis, Frank Watanabe, KB Ofosu, and Cliff Graham. The CAC members were Rodney Honeycutt, Adam Kohler, Peter Fusscas, Michael Wrazen, and Arlyn Deblauw.

The SCTPO offered technical assistance to Brevard County to apply for an Infrastructure Grant for the widening of Ellis Road, the SCTPO's top priority. Brevard County did not receive this award. SCTPO will assist with another application for the grant this year. SCTPO is coordinating with Brevard County and consultants to update modeling information that will help the development of the application.

Gillette provided an update on the carbon reduction program funding. The state of Florida has told the US DOT that it will not comply with setting performance targets for greenhouse gas emissions and developing a carbon reduction plan. This may affect Brevard County because Florida was set to get roughly \$320 million from the federal government from the infrastructure bill for the carbon reduction program. SCTPO's budget has carbon reduction funds programmed on quite a few projects. SCTPO receives roughly \$1.5 million per year from the infrastructure bill and has been very aggressively programming it on various projects. SCTPO will continue to work with DOT partners and seek guidance from DOT District 5 office. February 1st was the deadline for the department to set those targets and it has now been extended to March 29th. MPOs have 180 days to set targets after the DOT adopts their target. The DOT does not plan on adopting a target which means the MPOs will have to discuss how to move forward.

Gillette wanted to highlight a transportation bill, Senate bill 1032. It is a very broad transportation bill. This bill has significant impacts to MPOs and statewide transportation planning. This will require the DOT to review each MPOs long range transportation plan to ensure there is connectivity between people and freight and to ensure that it is

progressively implemented. If the plan is found to be unsatisfactory, the DOT will return the plan to the MPO for revision. It will also require DOT to set policy performance metrics and a minimum acceptable score to rate each MPOs service to its communities, taking into consideration traffic congestion, the utilization rate of multimodal transportation facilities, resident satisfaction, and efficiency of the transportation system. Any MPO that does not achieve the minimum acceptable score could potentially be taken over by the DOT secretary who would appoint a new Executive Director and a new Chair of the TPO Governing Board, potentially restructure the Governing Board, and potentially merge MPOs. If the MPO gets the top score, they will receive a \$5 million prize to go toward any project. The bill would also abolish the MPO Advisory Council and the Florida Transportation Commission that recommends the DOT secretary to the Governor. This house bill is moving through several committees. No one knows where this bill is coming from, but it is being discussed in detail.

Pete Petyk commented about a potential financial motive behind the bill.

Christy Fischer asked if FDOT is being held accountable similar to the MPOs? Gillette replied that this bill would put DOT in a terrible position. Gillette stated, as MPOs we control some federal funding but certainly not all funding. There is a very long priority list with projects that are not moving, majority of them on state road. The department is not taking a position on this, but it is hard to imagine that DOT would want to take over an MPO. Florida has one of the best transportation systems in the country because of the collaboration between MPOs and the department.

Philip Weinberg recommended that if any members of the TAC/CAC have interactions with any legislative delegation to express total opposition to SB 1032.

Ginger Twigg asked if anyone has spoken to the Senator that proposed the bill. Gillette replied that letters have been sent to the Senator and that Mark Reichert met with Representative McFarland but was not able to get any information. If someone knows where this bill is coming from, they are not saying. It is possible that the bill could be from a lack of understanding MPOs contributions.

Action Items:

<u>Item 5A. Adoption RE: Resolution 24-13: SCTPO Vision Zero Action Plan Update</u>

The SCTPO's vision of providing a safe, multimodal, innovative, and resilient transportation system for all requires improving the safety of Brevard County's transportation system. The SCTPO has a long history of supporting safety efforts to increase awareness, including the adoption of resolution of support for Vision Zero and the development of the 2020 Vision Zero Action Plan in 2019.

Vision Zero's philosophy is that traffic fatalities and serious injuries can be prevented, and the absolute minimum acceptable number is zero. Vision Zero is a data driven, multi-disciplinary approach bringing together diverse and necessary stakeholders to address this complex problem and requires a fundamental change in the way we think about traffic safety and planning.

As the 2020 Vision Zero Action Plan strategies and goals were accomplished, the SCTPO began the task of updating the Plan. This 2024 Vision Zero Action Plan focuses on the next phase of efforts to achieve zero fatalities and serious injuries on our roadways, and better serves our community through the development of new strategies, targets, and best practices identified in recent years.

TPO staff have prepared a resolution adopting the updated 2024 Vision Zero Action Plan to further guide their efforts towards zero traffic deaths and serious injuries on Brevard County roads. The resolution serves as a commitment to the 2024 Action Plan, establishes the SCTPO's first target goal of 2050, and encourages local municipalities to consider developing and adopting Action Plans for their respective jurisdictions.

Christy Fischer commented that inexpensive things can be done to intersections with paint and if working with the County is possible to implement this type of improvement. Shelby Villatoro replied that this is something that TPO encourages but it falls to the agencies to implement.

Gregg Stoll commented that he would like to see a safety pop-up in relation to rail crossing safety. He asked if Georganna Gillette if she could speak to any potential grants for additional safety measures to implement at the crossings that meet FRA specifications but could be enhanced. Georganna Gillette replied that the SCTPO is in contact with Brightline. There is an item for the TPO Governing Board, with their approval the SCPTO is going to potentially take the lead on applying for a grant for safety improvements on the ten rail crossing locations that do not have certain safety improvements. The SCTPO is in coordination with Brevard County, the City of Melbourne, and the City of Cocoa but we must wait for the Grant Opportunity to come

out. There is also a RAISE grant where DOT and Brightline partnered together that is in the works to add delineators and low cost improvements.

Pete Petyk commented that he would like to see more pedestrian crossings and pavement markings. He also commented that there should be strict enforcement against those who do not stop for pedestrians in a crosswalk. Gillette commented that enforcement is a big part of safety. Engineering and education are important, but people have potentially trespassed across rail crossing for years and the problem now is that the train is moving too fast to get away with that.

Eric Fielding asked if the Vision Zero Action Plan is published annually. Villatoro replied that the SCTPO uses the Action Plan to do an annual report that provides updates on the tracked progress and the Action Plan is updated as needed.

Shelby Villatoro commented to Petyk's comment about enforcement and mentioned that the County just partnered with Best Foot Forward to do crosswalk enforcement and will be deliberately going out and writing tickets for people that do not stop at crosswalks.

TAC motion Devin Swanson, second by Christy Fischer to adopt the SCTPO Vision Zero Action Plan Update. CAC motion by Gregg Stoll, second by Arlyn Deblauw, to concur with the TAC motions. Hearing no objections, the CAC motion passed unanimously. The TAC motion passed unanimously.

Presentations:

Item 6A. Member Orientation (Transportation Planning 101)

Each year, the SCTPO provides a Member Orientation to familiarize new and existing members with functions, priorities, and strategic plan objectives.

SCTPO Executive Director Georganna Gillette will provide an overview of the nature of SCTPO, what we do, and your role as a member of the committee or governing board.

Pete Petyk commented on homeless citizens losing their lives near railroad crossings. Gillette replied that the SCTPO is coordinating with local governments about the grant mentioned, the county or the cities will have to provide a 20% non-federal match and once the improvements are put in, upon receival of an award, they are also going to have to maintain those improvements.

Ginger Twigg asked about remote attendance and if it will be offered in the future. Gillette replied that during the COVID-19 pandemic, remote meetings took place, but it was a process to set up the equipment and found that there was not a lot of participation in Brevard County, most members wanted to meet in person.

Reports:

<u>Item 7A. Florida Department of Transportation (FDOT) Report</u>

Chuck Koppernolle, FDOT MPO Liaison, reported to the Space Coast TPO Governing Board the status of various construction projects and engineering studies currently in progress in Brevard County.

Ginger Twigg asked if any LPI signals will be included in the intersections that have right turn lane additions. Koppernolle will find out and report back.

Jared Francis commented that at a recent Commission meeting in Cocoa Beach, it was voted to remove the raised crosswalks except for Northbound at South 21st Street.

Pete Petyk commented that raised crosswalks are intended to slow drivers down and he is disappointed that the City of Cocoa Beach is removing something that would benefit the pedestrians because of political expediency.

<u>Item 7B. Bicycle, Pedestrian and Trails Advisory Committee (BPTAC) Report</u>
Sarah Kraum reported on Bicycle, Pedestrian, & Trails Advisory Committee (BPTAC) and related Space Coast TPO activities.

At the most recent BPTAC Meeting of December 4th, the annual election of officers was held, the Long-Range Transportation Plan goals and objectives were presented, and the annual member orientation was held for the BPTAC. An upcoming visioning workshop was discussed and will be held on February 26, 2024.

Item 7C. Space Coast Area Transit Report

Space Coast Area Transit provided an update on recent activities and any changes of the transit system. Ken Harley reported that there have been increases in fixed route ridership. The Community Transportation Coordinator annual evaluation with Space Coast TPO was recently completed.

<u>Item 7D. Public Engagement Report</u>

The Space Coast TPO's Public Involvement Officer, Abby Hemenway, was absent from the meeting but the agenda package includes the updates on public participation efforts and initiatives.

SCTPO Staff led BPTAC members through a Strategic Visioning Workshop for the purpose of developing the vision, direction, and actions for the BPTAC.



The NASA Causeway Bridge is being reconstructed under a partnership between the FDOT, NASA, and Space Florida. 



The project proposes to upgrade mid-block crossings and add pedestrian-activated lights known as Rectangular Rapid Flashing Beacons (RRFBs) to enhance visibility of the crosswalks. A new pedestrian signal will also be added at Palm Avenue. Other improvements include reconstructing pedestrian curb ramps and driveways to comply with current ADA standards, modifying existing drainage, and upgrading pedestrian lighting.
- Update: The contractor received the revised project plans, and they are developing a
 new schedule for the revisions. They are currently grounding and performing electrical
 work in traffic control cabinets.

Agenda Items:

<u>Item 1. Call to Order of the Space Coast TPO Governing Board and Pledge of</u> Allegiance

SCTPO Governing Board Chair, Andrea Young called the meeting to order at 1:32 p.m. and welcomed those in attendance. All stood for the Pledge of Allegiance.

Item 2. Public Comment

Sandra Sullivan commented her concerns regarding funding for capacity projects and the need for county impact fees. She also commented concern regarding a bike lane installation project on the State Road 513 repaving. She mentioned her City of Satellite Beach requested a variance to allow golf carts to cross A1A and believes that golf carts/low speed vehicles need to be monitored.

Katie Delaney commented her concern that less than 5% of the FDOT budget goes to capacity needs. She believes the public should have an explanation as to why Space Florida is getting a large chunk of the FDOT budget. She commented that Highway 46 is one of the deadliest roads in North Brevard and believes that this road deserves some attention. She commented that she hopes to see more attendance from public officials at the SCTPO meetings and other transportation related meetings.

Reports:

Item 3A. Executive Director's Report

Georganna Gillette, SCTPO Executive Director, advised the Governing Board of any pertinent items not covered on the agenda. Perfect attendance for the 2023 TAC/CAC meetings was acknowledged. The members with perfect attendance were Councilmember Mimi Hanley, Vice-Mayor Yvonne Minus, Councilmember Don Willis.

Brevard County did not receive the INFRA Grant award for the Ellis Road widening. The only Florida project that was awarded was I-4 truck parking for \$180 million. There will be 917 truck parking spots along four sites on I-4. The SCTPO will work with consultants for when another INFRA grant opportunity is available.

There is correspondence in the agenda package explaining that the State of Florida has told USDOT that it will not comply with setting performance targets for greenhouse gas emissions and developing a carbon reduction plan. They believe that FHWA and the federal government has exhibited broad overreach in their implementation of the rule and has been left with no choice but to follow 20 other states and file a complaint in federal court requesting injunctive relief to the rule. FHWA has acknowledged the complaint and extending the deadline to set greenhouse gas emissions. TPO's are required to establish greenhouse gas targets no later than 180 days after the DOT. These are issues more national and political in nature but could affect Brevard County because we receive a percentage of the carbon reduction funding.

Gillette wanted to highlight a transportation bill, Senate bill 1032. It is a very broad transportation bill. This bill has significant impacts to MPOs and statewide transportation planning. This will require the DOT to review each MPO's long range transportation plan to ensure there is connectivity between people and freight and to ensure that it is

progressively implemented. If the plan is found to be unsatisfactory, the DOT will return the plan to the MPO for revision. It will also require DOT to set policy performance metrics and a minimum acceptable score to rate each MPOs service to its communities, taking into consideration traffic congestion, the utilization rate of multimodal transportation facilities, resident satisfaction, and efficiency of the transportation system. Any MPO that does not achieve the minimum acceptable score could potentially be taken over by the DOT secretary who would appoint a new Executive Director and a new Chair of the TPO Governing Board, potentially restructure the Governing Board, and potentially merge MPOs. If the MPO gets the top score, they will receive a \$5 million prize to go toward any project. The bill would also abolish the MPO Advisory Council and the Florida Transportation Commission that recommends the DOT secretary to the Governor. This house bill is moving through several committees. No one knows where this bill is coming from, but it is being discussed in detail.

Paul Gougelman commented that the latest word out of Tallahassee (the rumor) is that the revised version of SB 1032 is going to be combined with the DOT's transportation bill. If that happens then the MPOAC, which is the collective voice of all the MPOs in Florida, will be abolished July 1st resulting in more authority for FDOT. More talking points from Mr. Gougelman are in the agenda package.

Commissioner Feltner commented that a 7,000 level bill in the house is a committee bill so a committee bill doesn't move forward if the speaker does not want it to. If anyone is looking to see where it came from, it probably came from the fourth floor.

Mimi Hanley commented that it is her understanding that MPOs are federally mandated. Gillette replied that Paul Gougelman's legal opinion does describe this bill as against federal law. However, the MPOAC was created by Florida legislature. Gillette mentioned that this bill puts DOT in a terrible position especially regarding "customer satisfaction". MPOs do have authority over some federal funding but not all funding and not state funding; many of the problems are on state roads.

<u>Item 3B. Technical and Citizen's Advisory Committees (TAC/CAC) Report</u>
Georganna Gillette, SCTPO Executive Director – Space Coast TPO, reviewed the summary of actions taken at the February 5th TAC/CAC meeting.

<u>Item 3C. Bicycle, Pedestrian and Trails Advisory Committee (BPTAC) Report</u>
Sarah Kraum reported on Bicycle, Pedestrian, & Trails Advisory Committee (BPTAC) and related Space Coast TPO activities.

At the most recent BPTAC Meeting of December 4th, the annual election of officers was held, the Long-Range Transportation Plan goals and objectives were presented, and the annual member orientation was held for the BPTAC. An upcoming visioning workshop was discussed and will be held on February 26, 2024.

<u>Item 3D. Space Coast Area Transit Report</u>

Space Coast Area Transit provided an update on recent activities and any changes of the transit system. Terry Jordan reported that there is an increase in ridership over last year and Space Coast Area Transit continues to rebound after the pandemic. New vehicles have been delivered and they are working on the Intelligent Transportation Systems to put the vehicles in service. Passengers can now access Wi-Fi and charge their mobile devices while the vehicle is in service. They are in the process of purchasing another new vehicle. They are expecting to have three Paratransit vehicles built and delivered by the end of the year. Space Coast Area Transit is collaborating with the SCTPO for the transit development plan. Space Coast Area Transit is also meeting regarding a Mobility on Demand study which will look at fine tuning service that is currently operating in certain areas.

Mimi Hanley requested that a garbage receptacle be reinstalled at the bus stop on the corner of Sarno Road and Croton Road. Jordan replied that he will work toward having a large receptacle installed at that location.

Joe Robinson asked about the criteria for a shelter to be installed at a bus stop. Jordan replied that they first determine if the location can accommodate a shelter. Shelters require a certain setback from the roadway. Secondly, they look at ridership at the location. They often partner with agencies to make sure that there is collaboration with the local municipality. Robinson asked if Space Coast Area Transit is still pursuing the implementation of electric buses. Jordan replied that SCAT has ordered hybrid electric vehicles which allows the diesel engine to recharge the batteries so there is not a need for charging infrastructure. Space Coast Area Transit is interested in hybrid vehicles, not fully electric, because of the charging infrastructure and the range of the vehicles.

Yvonne Minus requested a secure bench for a bus stop on University Boulevard in Melbourne across the street from Hickory Point Apartments. Minus also asked about transportation in Barefoot Bay. Jordan replied that he will investigate replacing the bench if it is on a concrete slab and belongs to SCAT. If the bench is on the private property of the apartments, then SCAT can work with the whomever to replace the bench. He commented that Barefoot Bay has a vehicle for the seniors that is operated by Barefoot Bay residents. It is a 14 passenger van that they have access to and may use it for grocery and shopping errands. He can provide further information to the individuals that may need it. He also commented that Indian River County also provides service to that area.

Public Comment: Sandra Sullivan commented on the state of benches and shelters in South Patrick Shores.

Item 3E. Florida Department of Transportation (FDOT) Report

FDOT Staff reported to the Space Coast TPO Governing Board the status of various construction projects and engineering studies currently in progress in Brevard County.

Skip Williams commented on the safety project on A1A from Crescent Beach to Minuteman Causeway. He also commented on flooding on State Road 520. Georganna Gillette commented that the SCTPO will be involved in the project on State Road 520 causeway vulnerability study.

<u>Item 5B. Approval RE: Resolution 24-10: 2045 Long Range Transportation Plan</u> Amendment No. 5

There are occasionally times when the Space Coast Transportation Planning Organization may find it necessary to amend the Long Range Transportation Plan (LRTP), outside of the 5-year update cycle.

SR 524 Widening project has been updated to reflect a funding change in Table 11.2: Other Arterial (State/Federal Funds) Projects of the LRTP with an estimated cost of \$7.4 million for design in FY 25.

The amendment also includes a minor administrative update in Table 11:4 Mixed Funding Projects, Malabar Road Widening project of the LRTP with an estimated cost of \$9.975 million for design in FY 24. The changes will not impact the cost feasibility of current or future projects.

The SCTPO seeks to amend the 2045 LRTP by Resolution 24-10, 2045 Long Range Transportation Plan Amendment No. 5 to comply with planning consistency requirements.

This resolution was included on the SCTPO Governing Board's December 14, 2023, action items for approval. However, due to quorum not being established, no actions were approved. Waiting for the next regularly scheduled Governing Board meeting for approval would have caused unnecessary delays in FDOT operations.

On December 18, 2023, the SCTPO Executive Director approved Resolution 24-10: 2045 Long Range Transportation Plan Amendment No. 5. This approval was in accordance with SCTPO Policy, PLC-3, Section 7.0(C)(1) SCTPO Executive Director Approval Authority, Emergency Circumstances.

Motion by Rob Medina, second by Michael Blake, to approve Resolution 24-10: 2045 Long Range Transportation Plan Amendment No.5. Motion passed unanimously via roll call vote 11-0.

<u>Approval RE: Resolution 24-11: FY 24 – 28 Transportation Improvement Program Amendment</u>

The Florida Department of Transportation requested an amendment to the adopted FY 24 – FY 28 Transportation Improvement Program to align with the Department's Work Program.

A project must be included in the approved TIP and State Transportation Improvement Program (STIP) for the FHWA and the FTA to participate in the cost of any federally funded transportation project.

The TIP reflects the TPO's priorities, consistent with port and aviation master plans, transit development plans and local government comprehensive plans, and are selected in part based on the public comment received under the TPO's Public Participation process.

This resolution was included on the SCTPO Governing Board's December 14, 2023, action items for approval. However, due to quorum not being established, no actions were approved. Waiting for the next regularly scheduled Governing Board meeting for approval would have caused unnecessary delays in FDOT operations.

On December 18, 2023, the SCTPO's Executive Director approved Resolution 24-11: FY 24 – 28 TIP Amendment No. 2. This approval was in accordance with SCTPO Policy, PLC-3, Section 7.0(C)(1) SCTPO Executive Director Approval Authority, Emergency Circumstances.

Motion by Michael Blake, second by Yvonne Minus, to approve Resolution 24-11: FY 24 – 28 Transportation Improvement Program Amendment. Motion passed unanimously via roll call vote 11-0.

Item 5D. Adoption RE: Resolution 24-13, SCTPO Vision Zero Action Plan Update

The SCTPO's vision of providing a safe, multimodal, innovative, and resilient transportation system for all requires improving the safety of Brevard County's transportation system. The SCTPO has a long history of supporting safety efforts to increase awareness, including the adoption of resolution of support for Vision Zero and the development of the 2020 Vision Zero Action Plan in 2019.

Vision Zero's philosophy is that traffic fatalities and serious injuries can be prevented, and the absolute minimum acceptable number is zero. Vision Zero is a data driven, multi-disciplinary approach bringing together diverse and necessary stakeholders to address this complex problem and requires a fundamental change in the way we think about traffic safety and planning.

As the 2020 Vision Zero Action Plan strategies and goals were accomplished, the SCTPO began the task of updating the Plan. This 2024 Vision Zero Action Plan focuses on the next phase of efforts to achieve zero fatalities and serious injuries on our roadways, and better serves our community through the development of new strategies, targets, and best practices identified in recent years.

TPO staff have prepared a resolution adopting the updated 2024 Vision Zero Action Plan to further guide their efforts towards zero traffic deaths and serious injuries on Brevard County roads. The resolution serves as a commitment to the 2024 Action Plan, establishes the SCTPO's first target goal of 2050, and encourages local municipalities to consider developing and adopting Action Plans for their respective jurisdictions.

Public Comment: Sandra Sullivan commented that electric micro mobility devices and vehicle, specifically golf carts, should be included in the educational programs of the SCTPO.

Motion by Joe Robinson, second by Michael Blake, to adopt Resolution 24-13, SCTPO Vision Zero Action Plan Update. Hearing no objections, the motion passed unanimously.

<u>Item 5E. Approval RE: Brevard Rail Safety - Grant Opportunity</u>

Initial discussions have begun with stakeholders to begin early coordination to apply for a discretionary grant from the Federal Railroad Administration (FRA). Through the Bipartisan Infrastructure Law (BIL), several grant opportunities are expected in the coming months.

Brightline has installed all the required safety improvements through their construction phase for the intercity passenger rail. Additional improvements were awarded through a RAISE grant that include signage, delineators and other supplemental safety measures that would improve safety along the Florida East Coast Rail Corridor including Brevard County. Construction of these improvements are forthcoming.

Through a potential new grant opportunity, additional safety improvements will be evaluated at 10 crossing locations in Brevard County. In order to be prepared and ready to submit for this or any other future grant opportunities, it is being requested that the SCTPO Executive Director be granted authorization to utilize consultant services via work orders for grant development support and be authorized to execute all documentation related to grant submission and award of such that would provide additional supplemental safety improvements along the FEC Rail corridor.

Motion by Rob Medina, second by Michael Blake, to authorize SCTPO Executive Director to execute consultant Work Orders for grant development and submission support and all subsequent documentation regarding Discretionary Grant Submissions and Award related to rail safety. Hearing no objections, the motion passed unanimously.

Item 6A. Member Orientation (Transportation Planning 101)

Each year, the SCTPO provides a Member Orientation to familiarize new and existing members with functions, priorities, and strategic plan objectives.

SCTPO Executive Director Georganna Gillette provided an overview of the nature of SCTPO, what we do, and your role as a member of the committee or governing board. Michael Blake commented as a new member, that he is happy to a part of the SCTPO, and he will abide by all policies and procedures, and he believes in the organization.

DISCUSSION

- 1. The current Unified Planning Work Program (UPWP) expires on June 30, 2024. A few projects have been funded with FY 24 SU grant funds that will not be completed until after the June 30th deadline, along with some that are being deferred until the new fiscal year. Therefore, a de-obligation of funds must be processed in order for the funds to be "rolled forward" into the new fiscal year and be available without interruption to projects. Projects that are in progress or being initiated prior to July 1, 2024 include: 2050 Long Range Transportation Plan/Transit Development Plan, Southern Brevard Trails Master Plan, Dixon Bvld. Complete Street Study and annual State of the System Report. The requested amount of FY 24 SU funds to de-obligate is \$416,553. The de-obligated funds will be reflected in the upcoming final FY 25-26 UPWP.
- <u>2.</u> The closeout of FY 23 Operating Budget (October 1, 2022-September 30, 2023) has been completed. A balance forward in the amount of \$13,762 needs to be recognized and programmed in the current FY 23 operating budget in order to be expended. Adjustments to reflect actual grant balances as of October 1, 2023 are also included in the amendment along with the above adjustment to de-obligate FY 24 SU funds. Total adjustment to operating budget is a net reduction of \$172,864.
- <u>3.</u> The final quarterly report for FY 23 (Q4) and the first quarterly report for FY 24 (Q1) have been completed. Revenues and Expenditures are as anticipated.

- Approves the de-obligation of FY 24 funds and amended budget for the adopted FY 22/23 – FY 23/24 Unified Planning Work Program; and
- 2. Authorizes amending the associated Planning Grant Agreement, reflecting the amended funding amounts for FY 24.

DISCUSSION

Space Coast Transportation Planning Organization (TPO) initiated the annual Community Transportation Coordinator (CTC) evaluation on November 9, 2023. The evaluation is required per FAC 41-2.012 (5)(b) of the Commission for the Transportation Disadvantaged. The Space Coast TPO serves as the Designated Official Planning Agency (DOPA), which facilitates the evaluation of the CTC's performance in general and relative to the Commission's and local standards as referenced in rule 41-2.006, FAC. The evaluation must also be in compliance with the applicable provisions of Chapter 427, Rule 41-2 and 14-90.

The evaluation ensures the most cost-effective, efficient, and appropriate transportation services are provided to the entire transportation disadvantaged population of Brevard County. The evaluation documented the CTC's performance from July 1, 2022 through June 30, 2023.

The evaluation was conducted utilizing the Commission for the Transportation Disadvantaged CTC Evaluation Workbook. The workbook outlined the formal process for the CTC Evaluation.

FY 2023 CTC Evaluation Recommendations

- 1. Space Coast Area Transit must ensure that there are eligibility applications and supporting documents for each client.
- 2. Space Coast Area Transit must ensure that each Coordination Contractor provide the data for the Annual Operating Report on a quarterly basis. This needs to be done starting with the new State Fiscal Year in July 2024.
