What is the role of the Space Coast Transportation Planning Organization (Space Coast TPO)?

The Space Coast TPO is governed by federal and state law. Urban areas with a population more than 50K must have a TPO to spend federal transportation funds. A TPO is created to look at the big picture of transportation planning – helping to assist in the communication and coordination among the different modes and municipalities.

What is transportation planning?

Transportation planning is about identifying opportunities to improve mobility for the people and businesses who use transportation systems; it is about providing accessibility for everyone in your community.

What part does the SCTPO play?

The SCTPO adopts long-range plans and short-range programs for future transportation improvements. These decisions are guided by committees of citizens and technical experts as well as public input.

Featured Projects

PROJECT SPOTLIGHT:

Ellis Road Widening

In 2023, the SCTPO collaborated with various partners to advance its #1 priority project, the widening of Ellis Road from John Rodes Blvd. to Wickham Road. 2023 activities included reaffirming and applying for a USDOT INFRA Grant. Partnerships include Brevard County, the Florida Department of Transportation, the City of Melbourne, the City of West Melbourne and the Melbourne Orlando International Airport.

Right of Way acquisition is underway. Collectively, our team has already invested \$34.1M into the construction phase due to the urgency of the project's transportation infrastructure challenge. As we head into 2024, discussions continue on how to fully fund the project.



PROJECT SPOTLIGHT:

Transportation Resiliency Master Plan

To celebrate the adoption of its Transportation Resiliency Master Plan, the SCTPO held its Ride the Wave to Resiliency Community Symposium in March, where transportation planners,



resiliency advocates, engineers, technical consultants, citizens, municipal representatives, and environmental experts enjoyed hearing from local and regional professionals who discussed resiliency efforts, emergency management responses, and creative solutions.

Featured speakers included the Florida Department of Transportation (FDOT) District Five (D5) Secretary, John E. Tyler P.E., and representatives from Brevard County Emergency Management, Canaveral Port Authority, the City of Cape Canaveral, and FDOT D5 Regional Transportation Management Center (RTMC).

The Transportation Resiliency Master Plan has been identified as a Noteworthy Practice in planning by the Florida Metropolitan Planning Organization Advisory Council.

PROJECT SPOTLIGHT:

Advancing Regional Connections

In January, the SCTPO launched the Regional Intermodal Connections Committee (RICC) with the goal of exploring passenger rail connections, support, and partnerships. The RICC met regularly from January through August and gained regional consensus on continuing to study the feasibility of an intermodal passenger rail station In Brevard County.






PROJECT SPOTLIGHT:

Intermodal Station Feasibility Study

With a previously identified site near Clearlake Road and SR 528, an Intermodal Station Feasibility Study, funded by the FDOT Intermodal Program, was launched and a steering committee was formed to:

- Identify opportunities for implementing transit oriented development
- Reveal barriers to implementing a station
- Foster partnerships to strengthen connections and destinations
- Provide stakeholder feedback, insight, and direction

Heading into 2024, the SCTPO continues to lead a regional conversation around advancing a passenger rail station in Brevard County and works as a collaborative partner with Brightline to align its long-term vision.



Vision Zero in Action

Vision Zero: Taking Action Together Workshop

In June, we advanced the conversation about strategic implementation strategies that prioritize safety for all road users by hosting a Vision Zero focused workshop. Our local safety advocates, engineers, technical consultants, law enforcement, and local municipal elected leaders and staff participated in this event and learned about real-life regional success stories from FDOT D5, the Florida Bicycle Association, Bike/Walk Central Florida, the City of Orlando, and the Florida Law Enforcement Liaison Program.





Focusing on our High Injury Network

The High Injury Network (HIN), using crash data from 2018–2022, allows us to target safety improvements, and education efforts, along roadways and at intersections with the most severe crashes.

World Day of Remembrance

In November, the SCTPO recognized World Day of Remembrance for Road Traffic Victims. We paused and honored the victims whose stories were tragically stopped short or have been severely impacted due to traffic crashes.

Families gathered together to remember their loved ones and to take action together, as we heard from local leaders who underscored the importance of cultural change – to recognize that one death on our roadways is too many. The SCTPO recognizes that change is vital and we are committed to safety on our roadways.





Advancing Safety

Helmet Fit Certification Classes

Our team hosted multiple helmet fit certification courses in 2023. These courses increase our reach, as participants who become certified can order helmets and safety resource materials to distribute in their own communities. Creating this network of safety superheroes contributes to the overall mission of Vision Zero.







School Trailer Program Training

In September, the SCTPO led a teacher training for Brevard Public Schools PE teachers. Attendees learned various aspects of the bicycle and pedestrian safety curriculum. They even took it to the streets to experience what their students would learn through the program. Eleven new schools are now able to reserve our trailers equipped with bicycles and gear to teach safety lessons.

School Route Analysis Program

The School Route Analysis (SRA) program assesses safety and mobility improvements within designated study areas around schools.

The program's purpose is to create a safer environment for both students who live within the walk zone and choose to walk or bike to school, as well as creating safe routes for student drivers.



This program includes a detailed study process that evaluates study areas through observed vehicular, pedestrian, and bicycle circulation routes near to the school site, identifying issues associated with student drivers, pedestrians, and bicyclists within the study area, and developing recommendations for improvements.



In 2023, the SCTPO held field visits at several schools within the cities of Cocoa and Rockledge. Reports and Summary Booklets were created for each completed school.

Advancing Long Range Plans

Overview of our Long Range Plan Updates

The SCTPO's **Long Range Transportation Plan (LRTP)** is a planning document required by the U.S. DOT for the purpose of planning and programming federal and state transportation funds. The Plan reflects our community's transportation goals and priorities over the next 25 years.

A **Transit Development Plan (TDP)** is a planning document that is required by FDOT. The TDP defines public transportation needs within the region. The TDP plans for transit service, operations, and facilities over the next 10 years.

These two plans have not historically been developed in coordination with one another but in 2023, we invited our local governments, stakeholders, and the public to help us advance our long range plans together.

2023 State of Transportation

In November, the SCTPO hosted its State of Transportation event to kick off the development of the 2050 Long Range Transportation Plan. Local leaders, modal agency representatives, and regional partners had the chance to speak with the event's 80+ attendees about their unique focus areas, challenges, and plans for the future. The overlapping themes included:

- Transportation Resiliency
- Linking Transportation to Land Use
- Connectivity
- Safety/Vision Zero

- Space Travel
- Completion of Major FDOT Projects
- Widening of Ellis Road

Transit Ridership Survey

Feedback from both Space Coast Area Transit riders and non-riders alike helps us plan for the transit system's future needs.

From October to December, over 600 surveys were collected both online and in-person. In addition to meeting and listening to Space Coast Area Transit riders on the bus and at bus transfer stations, the online survey was promoted through onbus advertisements, signage at the Space Coast Area Transit North Terminal, and on social media.

What's Next?

Advance 2050 will develop a transportation budget for the next 25 years through prioritizing community needs into a Cost Feasible Plan.

Over 100 days ahead of schedule, Lieutenant Governor Jeanette Nuñez, the FDOT, NASA, and Space Florida celebrated the completion of the NASA Causeway Bridge with a ribbon cutting in June 2023. The NASA Causeway Bridge accounts for the booming commercial aerospace activity on the Space Coast and provides a taller and wider fixed overpass over the Indian River Lagoon and eliminates the need for a drawbridge.
