WHEREAS, the Transportation Improvement Program (TIP) is hereby endorsed as an accurate representation of the areas priorities as developed through the planning process carried on cooperatively by the state and local communities in accordance with the provisions of 23 U.S.C. 134.; and

**Difference:** Construction phase and funds have been added to the project in FY 2021/2022. PD&E (In-House) funds have also been added in FY 2020/2021.

**Explanation:** Construction has been programmed into the Department's Work Program System for Fiscal Year 2022 due to the availability of funding. The TIP must be updated to reflect the available funds in Fiscal Years 2020/2021 – 2024/2025. The TIP amendment must be approved before the FDOT Statewide TIP (STIP) can be amended. Construction projects (contract class 1) are processed 60-90 days prior to letting in the financial accounting system. The STIP must be processed in April to meet the project's current schedule.

The funding will allow for the replacement of the existing twin bascule bridges constructed in 1964 with new twin high-level bridges. Project includes minor roadwork and new drainage ponds.

**Explanation:** This project is a LAP with Brevard County. FPID #441778-1 previously had funding programmed for design, construction and CEI. As a jurisdictional right-of-way transfer from the Department to Brevard County is forthcoming, it was decided to treat this project as off-system, which changed the transportation system in Work Program for the construction phase. In addition, the 90% cost estimate indicated that the project costs were higher than the programmed funding, so the TPO added this project to the priority list to allow for additional funding.

Due to the Work Program change in transportation system, and the additional funding needed, it was decided to leave design under 441778-1 and to shift construction funding to 441778-2.

Additionally, this project will be utilizing the District 5 Continuing Services Contract for CEI, so CEI funding was shifted to 441778-3 to allow for the change of contract type.
